Dawlada Mareykanku waxay diidaysaa gudniinka fircooniga ah (FGM/C), nooc kastaba, heerkasta, ama siduu doono ha u darnaadee, oo sababkastaba ha loo sameeyee. Dawlada Mareykanku waxay fahamsan tahay in gudniinka fircooniga ah (FGM/C) la fulin karo iyadoo la raacayo dhaqano la aamisan yahay oo ka qeyb ah caadooyinka dadka waaweyn. Haseyeeshee, dawlada Mareykanku waxay u aqoonsan tahay gudniinka fircooniga ah (FGM/C) inuu yahay ku xadgudub xuquuq binaadamino oo daran, iyo nooc rabshad jinsi iyo xadgudub caruureed ah.

Mareykanka wax aka go'an soo-afjarida FGM/C.
