





**DISCUSSION:** The preference visa petition was denied by the Director, Vermont Service Center, and is now before the Associate Commissioner for Examinations on appeal. The appeal will be dismissed.

The petitioner is textile design company. It seeks to employ the beneficiary permanently in the United States as a textile designer. As required by statute, the petition is accompanied by an individual labor certification approved by the Department of Labor. The director determined that the petitioner had not established that it had the financial ability to pay the beneficiary the proffered wage as of the filing date of the visa petition.

On appeal, counsel provides a statement and requests 60 days in which to submit a brief and/or additional evidence. No further documentation, however, has been received. Therefore, a decision will be made based on the record as it is presently constituted.

Section 203(b)(3)(A)(i) of the Immigration and Nationality Act (the Act), 8 U.S.C. 1153(b)(3)(A)(i), provides for the granting of preference classification to qualified immigrants who are capable, at the time of petitioning for classification under this paragraph, of performing skilled labor (requiring at least two years training or experience), not of a temporary or seasonal nature, for which qualified workers are not available in the United States.

8 C.F.R. 204.5(g)(2) states in pertinent part:

*Ability of prospective employer to pay wage.* Any petition filed by or for an employment-based immigrant which requires an offer of employment must be accompanied by evidence that the prospective United States employer has the ability to pay the proffered wage. The petitioner must demonstrate this ability at the time the priority date is established and continuing until the beneficiary obtains lawful permanent residence. Evidence of this ability shall be either in the form of copies of annual reports, federal tax returns, or audited financial statements.

Eligibility in this matter hinges on the petitioner's ability to pay the wage offered as of the petition's filing date, which is the date the request for labor certification was accepted for processing by any office within the employment system of the Department of Labor. Matter of Wing's Tea House, 16 I&N Dec. 158 (Act. Reg. Comm. 1977). Here, the petition's filing date is January 6, 1998. The beneficiary's salary as stated on the labor certification is \$28.32 per hour or \$58,905.60 per annum.

Counsel submitted copies of the beneficiary's W-2 Wage and Tax Statement which showed she was paid \$26,000.00 in 1998, \$30,000.00 in 1999, and \$30,000.00 in 2000, and copies of the petitioner's 1998, 1999, and 2000 Form 1120 U.S. Corporation Income Tax Return. The tax return for 1998 reflected gross receipts of \$131,479; gross profit of \$90,741; compensation of officers of \$30,000; salaries and wages paid of \$26,000; and a taxable income before net operating loss deduction and special deductions of \$8,973.

The federal tax return for 1999 reflected gross receipts of \$129,039; gross profit of \$90,499; compensation of officers of \$30,000; salaries and wages paid of \$30,000; and a taxable income before net operating loss deduction and special deductions of \$190. The federal tax return for 2000 reflected gross receipts of \$123,709; gross profit of \$95,437; compensation of officers of \$21,000; salaries and wages paid of \$30,000; and a taxable income before net operating loss deduction and special deductions of \$5,500.

The director determined that the evidence submitted did not establish that the petitioner had the ability to pay the proffered wage and denied the petition accordingly.

On appeal, counsel argues that the owner of the petitioning entity could use his personal funds to offset the beneficiary's wage.

Counsel's argument is not persuasive. The petitioning entity in this case is a corporation. Consequently, any assets of the individual stockholders including ownership of shares in other enterprises or corporations cannot be considered in determining the petitioning corporation's ability to pay the proffered wage. See Matter of M, 8 I&N Dec. 24 (BIA 1958; AG 1958); Matter of Aphrodite Investments Limited, 17 I&N Dec. 530 (Comm. 1980); and Matter of Tessel, 17 I&N Dec. 631 (Act. Assoc. Comm. 1980).

The petitioner's Form 1120 for calendar year 1998 shows a taxable income of \$8,973. The petitioner could not pay a proffered wage of \$58,905.60 a year out of this figure

In addition, the tax returns for calendar years 1999 and 2000 continue to show an inability to pay the wage offered.

Accordingly, after a review of the federal tax returns submitted, it is concluded that the petitioner has not established that it had sufficient available funds to pay the salary offered at the time of filing of the petition.

The burden of proof in these proceedings rests solely with the petitioner. Section 291 of the Act, 8 U.S.C. 1361. The petitioner has not met that burden.

**ORDER:** The appeal is dismissed.
