



DISCUSSION: The Acting Director, Vermont Service Center, denied the third preference immigrant visa petition in this matter. The Director, Vermont Service Center, reopened the matter pursuant to a subsequent motion and denied the visa petition again. The matter is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected as untimely filed.

The regulation at 8 C.F.R. § 103.3(a)(2)(i) provides that the affected party, in order to properly file an appeal, must file the complete appeal within 30 days after service of the unfavorable decision. If the decision was mailed, the appeal must be filed within 33 days. *See* 8 C.F.R. § 103.5a(b).

The record indicates that the director issued the decision on the motion on January 13, 2005. The director properly gave notice to the petitioner that it had 33 days to file the appeal. Citizenship and Immigration Services (CIS) received the appeal on February 16, 2005, 34 days after the decision was issued. The appeal, therefore, was untimely filed.

The regulation at 8 C.F.R. § 103.3(a)(2)(v)(B)(2) states that, if an untimely appeal meets the requirements of a motion to reopen or a motion to reconsider, the appeal must be treated as a motion, and a decision must be made on the merits of the case. The official having jurisdiction over a motion is the official who made the last decision in the proceeding, in this case the service center director. *See* 8 C.F.R. § 103.5(a)(1)(ii). The director declined to treat the late appeal as a second motion and forwarded the matter to the AAO.

As the appeal was untimely filed, the appeal must be rejected.

ORDER: The appeal is rejected.
