

If you believe the law was inappropriately applied or the analysis used in reaching the decision was inconsistent with the information provided or with precedent decisions, you may file a motion to reconsider. Such a motion must state the reasons for reconsideration and be supported by any pertinent precedent decisions. Any motion to reconsider must be filed within 30 days of the decision that the motion seeks to reconsider, as required under 8 C.F.R. § 103.5(a)(1)(i).

If you have new or additional information that you wish to have considered, you may file a motion to reopen. Such a motion must state the new facts to be proved at the reopened proceeding and be supported by affidavits or other documentary evidence. Any motion to reopen must be filed within 30 days of the decision that the motion seeks to reopen, except that failure to file before this period expires may be excused in the discretion of Citizenship and Immigration Services (CIS) where it is demonstrated that the delay was reasonable and beyond the control of the applicant or petitioner. *Id.*

Any motion must be filed with the office that originally decided your case along with a fee of \$110 as required under 8 C.F.R. § 103.7.

DISCUSSION: The immigrant visa petition was denied by the Director, Nebraska Service Center. An appeal was dismissed by the Associate Commissioner for Examinations, now the Administrative Appeals Office (AAO). The matter is now before the AAO on motion to reconsider. The motion will be dismissed.

The petitioner is a church. It seeks classification of the beneficiary as a special immigrant religious worker pursuant to section 203(b)(4) of the Immigration and Nationality Act (the "Act"), 8 U.S.C. 1153(b)(4), in order to employ him as "assistant to the pastor."

The petitioner filed an appeal from the decision with additional evidence. The Associate Commissioner, by and through the Director, Administrative Appeals Office ("AAO"), reviewed the record and dismissed the appeal on April 24, 2002, finding that the petitioner had failed to overcome the grounds for denial.

The beneficiary now files a motion to reconsider.

Regulations at 8 C.F.R. § 103.(a)(1)(iii) state, in pertinent part:

(B) *Meaning of affected party.* For purposes of this section and sections 103.4 and 103.5 of this part, *affected party* (in addition to the Service) means the person or entity with legal standing in a proceeding. It does not include the beneficiary of a visa petition. (emphasis added.)

Regulations at 8 C.F.R. § 103.5(a)(3) state that: "A motion that does not meet applicable requirements shall be dismissed." Among applicable requirements, the regulations at 8 C.F.R. § 103.5(a)(1)(iii)(A) state that a motion must be by the affected party or the attorney or representative of record.

The motion has not been filed by the petitioner or the petitioner's attorney or registered representative, but rather by the beneficiary. Therefore, the motion must be dismissed.

ORDER: The motion is dismissed.
