



Any motion to reconsider must be filed within 30 days of the decision that the motion seeks to reconsider, as required under 8 C.F.R. 103.5(a)(1)(i).

If you have new or additional information which you wish to have considered, you may file a motion to reopen. Such a motion must state the new facts to be proved at the reopened proceeding and be supported by affidavits or other documentary evidence. Any motion to reopen must be filed within 30 days of the decision that the motion seeks to reopen, except that failure to file before this period expires may be excused in the discretion of the Service where it is demonstrated that the delay was reasonable and beyond the control of the applicant or petitioner. Id.

Any motion must be filed with the office which originally decided your case along with a fee of \$110 as required under 8 C.F.R. 103.7.

**DISCUSSION:** The nonimmigrant visa petition was denied by the Director, Texas Service Center, who certified the decision to the Associate Commissioner for Examinations for review. The decision of the director will be affirmed.

The petitioner is a wholesale nursery. It desires to continue to employ the beneficiary as a farm laborer for a period of one year. The petition was not accompanied by the required temporary agricultural labor certification, ETA-750. The director determined that absent the certification, the petitioner failed to meet the regulatory requirements necessary for approval of the petition.

The regulation at 8 C.F.R. 214.2(h)(5)(i)(A) states in pertinent part that:

An H-2A petition must be filed on Form I-129. This petition must be filed with a single valid temporary agricultural labor certification.

The regulation at 8 C.F.R. 214.2(h)(5)(i)(D) states in pertinent part that a H-2A petition:

will be automatically denied if filed without the certification evidence required in paragraph (h)(5)(i)(A) of this section....

The petition was filed on November 26, 1999 without a temporary agricultural labor certification. Absent such documentation, the petition cannot be approved.

The burden of proof in these proceedings rests solely with the petitioner. Section 291 of the Act, 8 U.S.C. 1361. Here, the petitioner has not met that burden.

**ORDER:** The appeal is dismissed.
