DISCUSSION: The service center director denied the nonimmigrant visa petition and the matter is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be summarily dismissed.

The petitioner is a retirement community. It seeks to employ the beneficiary as a social services coordinator, and endeavors to classify her as a nonimmigrant worker in a specialty occupation pursuant to section 101(a)(15)(H)(i)(b) of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1101(a)(15)(H)(i)(b).

As stated in 8 C.F.R. § 103.3(a)(1)(v), an appeal shall be summarily dismissed if the party concerned fails to identify specifically any erroneous conclusion of law or statement of fact for the appeal. The director determined that the proffered position did not qualify as a specialty occupation. Accordingly, the petition was denied.

On appeal, the petitioner states simply that it urgently needs the services of the beneficiary. Although the petitioner stated on the Form I-290B that it would file a brief within 30 days in support of the appeal, no brief has been filed. The petitioner has not specifically identified any erroneous conclusion of law or statement of fact upon which the appeal is based. The petitioner must do more than simply ask for an appeal. It must clearly demonstrate the basis for the appeal. This, the petitioner has failed to do. As such, the appeal must be dismissed.

The burden of proof in this proceeding rests solely with the petitioner. Section 291 of the Act, 8 U.S.C. § 1361. The petitioner has not sustained that burden.

ORDER: The appeal is dismissed.
