DISCUSSION: The nonimmigrant visa petition was denied by the Director, Nebraska Service Center. The matter is now before the Associate Commissioner for Examinations on appeal. The appeal will be dismissed.

The petitioner is a school that seeks to continue to employ the beneficiary as its director for a period of one year. The director determined that the petitioner had not submitted a temporary labor certification from the Department of Labor or notice stating that such certification cannot be made.

On appeal, counsel states that the unexplained delay of the Department of Labor in processing the original labor certification application caused the original approval to be useless to the applicant and merits an extension of the H2-B classification.

8 C.F.R. 214.2(h)(6)(iv)(A) requires that a petition for temporary employment in the United States be accompanied by a temporary labor certification from the Department of Labor, or notice detailing the reasons why such certification cannot be made.

The petition was filed on October 9, 2001 without a temporary labor certification, or notice detailing the reasons why such certification cannot be made. Absent such documentation, the petition cannot be approved.

The burden of proof in these proceedings rests solely with the petitioner. Section 291 of the Act, 8 U.S.C. 1361. Here, the petitioner has not met that burden.

ORDER: The appeal is dismissed.
