DISCUSSION: The Director, California Service Center, denied the application for permission to reapply for admission. The matter is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected as untimely filed.

In order to properly file an appeal, the regulation at 8 C.F.R. § 103.3(a)(2)(i) provides that the affected party must file the complete appeal within 30 days of service of the unfavorable decision. If the decision was mailed, the appeal must be filed within 33 days. *See* 8 C.F.R. § 103.5a(b).

The record indicates that the director issued the decision on April 21, 2006. It is noted that the director properly gave notice to the applicant that he had 33 days to file the appeal with the service center. The applicant incorrectly filed the appeal with the AAO on May 24, 2006. An appeal is not properly filed until the service center receives it. The AAO returned the appeal to the applicant and informed him that he had incorrectly filed the appeal with this office. Citizenship and Immigration Services (CIS) received the appeal on June 1, 2006, or 41 days after the decision was issued. Accordingly, the appeal was untimely filed.

The regulation at 8 C.F.R. § 103.3(a)(2)(v)(B)(2) states that, if an untimely appeal meets the requirements of a motion to reopen or a motion to reconsider, the appeal must be treated as a motion, and a decision must be made on the merits of the case. The official having jurisdiction over a motion is the official who made the last decision in the proceeding, in this case the director, California Service Center. *See* 8 C.F.R. § 103.5(a)(1)(ii). The director declined to treat the late appeal as a motion and forwarded the matter to the AAO.

As the appeal was untimely filed, the appeal must be rejected.

ORDER: The appeal is rejected.
