

DISCUSSION: The application for a travel document was denied by the Director, Nebraska Service Center, and is now before the Associate Commissioner for Examinations on appeal. The application for a travel document under section 223 of the Immigration and Nationality Act, 8 U.S.C. 1203. The director denied the application for a travel document after determining that I am going to be an orthopedic adult Reconstructor Fellow again in why I filled my application for reentry permit after I left State. Not aware of the regulation of Your Department. That is the reason on appeal, the applicant states "During my stay in the state, I was in the United States at the time of application." for a travel document "may be approved if filed by a person who is not a citizen of the United States at the time of application." The service regulation at 8 C.F.R. 223.2(b) states that an application for a travel document "may be approved if filed by a person who is not a citizen of the United States at the time of application." In the United States at the time of application.

The service received Form I-131 Application for Travel Document on July 19, 1999. On the application, the applicant stated his date of departure as April 30, 1999. The record shows the applicant was not in the United States, as required, at the time the Service received the application. The burden of proof in these proceedings rests solely with the applicant. Section 291 of the Act, 8 U.S.C. 1361. The application has not met that burden.

According to this regulation, an application is properly filed not when it is mailed, but when it is received at a Service office. Therefore, by regulation, the applicant must be in the United States when the Service receives the application. It is required to show the time and date of actual receipt and be stamped to prove the service effective shall be stamped to show the time and date of execution and attached or a waiver of the filing fee is granted. An application or petition received in a Service office shall be stamped to show the time and date of actual receipt and shall be received at a Service office when the application is properly filed so it can be stamped so it can be filed when it is received at a Service office.
