DISCUSSION: The termination of temporary resident status by the Director, California Service Center, is before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected.

The director terminated the applicant's status because the applicant had failed to apply for adjustment to permanent residence in a timely manner.

An alien may appeal a decision to terminate his or her temporary resident status to the Administrative Appeals Office. Any appeal with the required fee shall be filed with the service center within thirty (30) days after service of the notice of termination. 8 C.F.R. § 245a.2(u)(2)(i). An appeal received after the thirty day period has tolled will not be accepted. 8 C.F.R. § 103.3(a)(3)(iv)(C). Whenever a person has the right or is required to do some act within a prescribed period after the service of a notice upon him or her and the notice is served by mail, three days shall be added to the prescribed period. Service by mail is complete upon mailing. 8 C.F.R. § 103.5a(b).

A review of the record shows the Notice of Termination was issued on July 9, 1996, and was mailed to the applicant's address of record. The appeal was received on October 1, 2001. The appeal was untimely filed. Therefore, the appeal must be rejected.

ORDER: The appeal is rejected.
