



DISCUSSION: The application for temporary resident status as a special agricultural worker was denied by the Director, Northern Regional Processing Facility. The matter was remanded by the Administrative Appeals Office (AAO), and denied again by the Director, Nebraska Service Center. The matter is now before the AAO on appeal. The appeal will be dismissed.

The Director, Nebraska Service Center denied the application because the applicant failed to appear for fingerprinting. The applicant has not addressed the director's decision or provided any evidence to overcome the director's findings.

As of March 29, 1998, applicants for Temporary Resident Status as a Special Agricultural Worker (SAW) are required to be fingerprinted at a Citizenship and Immigration Services (CIS) Application Support Center or approved Designated Law Enforcement Agency.

On April 11, 1994, the case was remanded for the introduction of any additional adverse evidence. On May 6, 2005, a notice was sent to the applicant at her address of record, advising her to appear at the CIS office in Omaha, Nebraska on May 24, 2005, to be fingerprinted. The notice was returned by the post office as undeliverable. On December 9, 2005, the director denied the application because the applicant failed to appear for the required fingerprinting.

Declarations by an applicant that he /she has not had a criminal record are subject to verification of facts by CIS. The applicant must agree to fully cooperate in the verification process. 8 C.F.R. § 210.3(b)(3) states all evidence regarding admissibility and eligibility submitted by an applicant for adjustment of status will be subject to verification by the Service. Failure by an applicant to release information may result in the denial of the benefit sought. Additionally, 8 C.F.R. § 210.3(c) states in part: "A complete application for adjustment of status must be accompanied by proof of identity, evidence of qualifying employment, evidence of residence, and such evidence of admissibility or eligibility as may be required by the examining immigration officer in accordance with such requirements specified in this part."

The applicant failed to appear as required for fingerprinting. Consequently, the applicant has not met the required burden of proof establishing admissibility or eligibility for temporary resident status as a SAW.

ORDER: The appeal is dismissed. This decision constitutes a final notice of ineligibility.
