



**DISCUSSION:** On May 5, 2005, the applicant filed an application for status as a temporary resident pursuant to section 245A of the Immigration and Nationality Act, as amended, 8 U.S.C. § 1255a, under the terms of the settlement agreements reached in *Catholic Social Services, Inc., et al., v. Ridge, et al.*, CIV. NO. S-86-1343-LKK (E.D. Cal) January 23, 2004, and *Felicity Mary Newman, et al., v. United States Immigration and Citizenship Services, et al.*, CIV. NO. 87-4757-WDK (C.D. Cal) February 17, 2004, (CSS/Newman Settlement Agreements). The denial of the application for status as a temporary resident by the District Director, Los Angeles, is before the Administrative Appeals Office on appeal. The appeal will be rejected.

An adverse decision regarding temporary resident status may be appealed to the Administrative Appeals Office. Any appeal with the required fee shall be filed with the Regional Processing Facility within thirty (30) days after the date of the denial notice. An appeal received after the thirty-day period has tolled will not be accepted. 8 C.F.R. § 245a.2(p). Whenever a person has the right or is required to do some act within a prescribed period after the service of notice upon him and the notice is served by mail, three days shall be added to the prescribed period. Service by mail is complete upon mailing. 8 C.F.R. § 103.5a(b).

The director issued the denial notice on August 10, 2006, and mailed it to the applicant's address of record. The appeal was received as properly filed on September 13, 2006, thirty-four (34) days after the date indicated on the denial notice. Therefore, the appeal was untimely filed, and must be rejected.

**ORDER:** The appeal is rejected as untimely filed.
