

DISCUSSION: The application for permanent resident status under the Legal Immigration Family Equity (LIFE) Act was denied by the District Director, Dallas, Texas, and is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected.

The district director denied the application because the applicant had not demonstrated that she had continuously resided in the United States in an unlawful status since before January 1, 1982 through May 4, 1988.

An affected party filing from within the United States has 30 days from the date of an adverse decision to file an appeal. An appeal received after the 30-day period has tolled will not be accepted. The 30-day period for submitting an appeal begins 3 days after the Notice of Decision is mailed. 8 C.F.R. § 245a.20(b)(1)

The record reflects that the director sent her decision of January 14, 2004 to the applicant and to counsel at their addresses of record. Counsel dated the appeal February 17, 2004 and Citizenship and Immigration Services received the appeal 36 days after the issuance of the denial notice on February 19, 2004. Therefore, the appeal was untimely filed.

ORDER: The appeal is rejected as untimely filed.
