**DISCUSSION:** The District Director, Houston, denied the application for permanent resident status under the Legal Immigration Family Equity (LIFE) Act. The decision is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be summarily dismissed.

The director denied the application because the applicant had failed to establish that he entered the United States prior to January 1, 1982, and that he resided continuously since that date through May 4, 1988.

On his Form I-290B, Notice of Appeal to the AAO, filed on December 7, 2005, the applicant stated the following:

I like to reopen my case, so that I may continue with the process for my permanent residence.

The applicant did not allege any legal or factual error in the director's decision and did not submit additional documents. As of the date of this decision, no additional evidence has been submitted, and the record will be deemed complete.

Any appeal that fails to state the reason for appeal will be summarily dismissed. 8 C.F.R. § 103.3(a)(3)(iv). A review of the decision reveals that the director accurately set forth a legitimate basis for denial of the application. On appeal, the applicant has not presented additional evidence and has not addressed the basis for denial. The appeal must therefore be summarily dismissed.

**ORDER:** The appeal is dismissed. This decision constitutes a final notice of ineligibility.
