

DISCUSSION: The application was denied by the Director, Vermont Service Center (VSC), and is now before the Administrative Appeals Office (AAO) on appeal. The case will be remanded.

The applicant is stated to be a native and citizen of El Salvador who is seeking Temporary Protected Status (TPS) under section 244 of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1254.

The director's decision did not state a specific reason for the denial.

Counsel for the applicant filed an appeal and that appeal is now before the AAO.

On March 10, 2004, the director requested that the case be remanded to the VSC. Accordingly, without addressing the merits of the case, the appeal will be remanded to the director for further processing in accordance with his request.

It is noted that the evidence of record indicates that the applicant has another file number, [REDACTED], under which she has previously been granted a work authorization. Counsel indicates that this A-file number pertains to the applicant, in conjunction with the applicant's mother's asylum application [REDACTED] and that the applicant's mother was subsequently granted lawful permanent residence under the NACARA program.

As always in these proceedings, the burden of proof rests solely with the applicant. Section 291 of the Act, 8 U.S.C. § 1361.

ORDER: The director's decision is withdrawn. The case is remanded to the director for further consideration and action.
