DISCUSSION: The application was denied by the Director, Vermont Service Center, and is now before the Administrative Appeals Office (AAO) on appeal. The case will be remanded.

The applicant is stated to be a citizen of El Salvador who is seeking Temporary Protected Status (TPS) under section 244 of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1254.

The record reveals that the applicant filed her application on September 8, 2003. On October 14, 2003, the applicant was requested to submit evidence establishing her qualifying continuous residence in the United States as of February 13, 2001, and continuous physical presence in the United States since March 9, 2001. The director also requested the applicant to submit evidence to establish her eligibility for late registration. The record does not contain a response from the applicant; therefore, the director denied the application on January 26, 2004.

While the director's decision states: "the grounds for denial have not been overcome," the specific reason for the denial is not indicated. Under 8 C.F.R. § 103.3, "the officer shall explain in writing the specific reasons for denial."

The case is remanded for the issuance of a new decision that sets forth the specific reasons for the denial.

As always in these proceedings, the burden of proof rests solely with the applicant. Section 291 of the Act, 8 U.S.C. § 1361.

ORDER: The case is remanded to the director for entry of a new decision.
