**DISCUSSION:** The initial application was denied by the Director, Texas Service Center. A subsequent application for re-registration was denied by the Director, California Service Center, and is currently before the Administrative Appeals Office, (AAO), on appeal. The initial application will be reopened, *sua sponte*, by the Chief, AAO, and the case will be remanded for further consideration and action.

The applicant is a native and citizen of El Salvador who is seeking Temporary Protected Status (TPS) under section 244 of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1254.

The applicant filed an initial application for TPS under receipt number SRC 02 143 53577. The director denied the initial application on September 23, 2004, because applicant had abandoned his application by failing to appear for fingerprinting.

The applicant filed the current Form I-821, Application for Temporary Protected Status, on April 18, 2005, and indicated that he was re-registering for TPS.

In this case, the applicant has not previously been granted TPS because he had not appeared for fingerprinting. However, the record contains an Applicant Information Worksheet, showing that he appeared for fingerprinting at a Citizenship and Immigration Services office, that his prints were taken on October 14, 2004, and that they were processed for forwarding to the Federal Bureau of Investigation.

In this case, the director had information in the file indicating that the application could no longer be considered abandoned based on the failure to appear for fingerprinting issue. Therefore, a denial because the applicant had abandoned his case was not appropriate.

The director's denial of the initial application will be withdrawn; the application will be remanded for a new decision. The director's denial of the application for re-registration is also withdrawn as it is dependent upon the adjudication of the initial application. The director may request any evidence deemed necessary to assist with the determination of the applicant's eligibility for TPS.

It is noted that the burden of proof rests solely with the applicant. Section 291 of the Act, 8 U.S.C. § 1361.

**ORDER:** The initial application is reopened, the director's decision is withdrawn, and the application is remanded for a new decision. The re-registration application is remanded for further action consistent with the director's new decision on the initial application.
