DISCUSSION: The application was denied by the Director, California Service Center, and is now before the Administrative Appeals Office on appeal. The appeal will be dismissed.

The applicant is a citizen of El Salvador who is seeking Temporary Protected Status (TPS) under section 244 of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1254.

The applicant filed her initial TPS application during the initial registration period under Citizenship and Immigration Services (CIS) receipt number WAC 02 041 51257. The applicant's Federal Bureau of Investigation (FBI) fingerprint results report revealed the following offenses:

1. On July 5, 1996, the applicant was arrested in Los Angeles, California, and charged with "ADW VO FIREAMRS/GBI," a felony.
2. On October 1, 1996, the applicant was arrested in Los Angeles, California, and charged with "USE/UNDER INFLU CONTR SUBS," a misdemeanor.
3. On May 18, 1997, the applicant was arrested in Los Angeles, California, and charged with spouse beating, a felony.

On November 25, 2003, the applicant was requested to submit the final court dispositions of all arrests since her arrival in the United States. She was also requested to provide additional evidence to establish her qualifying continuous residence and continuous physical presence in the United States during the requisite periods. The record does not contain a response from the applicant. The director denied the application on March 31, 2004, due to abandonment because the applicant failed to respond to the request for evidence. The director informed the applicant that there is no appeal from a denial due to abandonment, but she could file a motion to reopen the case. The applicant failed to file a motion to reopen the case.

The applicant filed the current Form I-821, Application for Temporary Protected Status, on March 2, 2005, and indicated that she was re-registering for TPS or renewing her temporary treatment benefits.

The director denied the application on May 3, 2005, because the applicant's initial TPS application had been denied and the applicant was not eligible to apply for re-registration or renewal of her temporary treatment benefits.

If the applicant is filing an application as a re-registration, a previous grant of TPS must have been afforded the applicant, as only those individuals who are granted TPS must register annually. In addition, the applicant must continue to maintain the conditions of eligibility. 8 C.F.R. § 244.17. If an applicant is applying for renewal of temporary treatment benefits, he or she must have a pending TPS application.

In this case, the applicant has not previously been granted TPS. Therefore, she is not eligible to re-register for TPS or to renew temporary treatment benefits. Consequently, the director's decision to deny the application will be affirmed.

It is noted that the director's decision does not explore the possibility that the applicant was attempting to file a late initial application for TPS instead of an annual re-registration.

Section 244(c) of the Act, and the related regulations in 8 C.F.R. § 244.2, provide that an applicant may apply for TPS during the initial registration period, or:

- (f) (1) Registers for Temporary Protected Status during the initial registration period announced by public notice in the *Federal Register*, or
- (2) During any subsequent extension of such designation if at the time of the initial registration period:
 - (i) The applicant is a nonimmigrant or has been granted voluntary departure status or any relief from removal;
 - (ii) The applicant has an application for change of status, adjustment of status, asylum, voluntary departure, or any relief from removal which is pending or subject to further review or appeal;
 - (iii) The applicant is a parolee or has a pending request for reparole; or
 - (iv) The applicant is a spouse or child of an alien currently eligible to be a TPS registrant.
- (g) Has filed an application for late registration with the appropriate Service director within a 60-day period immediately following the expiration or termination of conditions described in paragraph (f)(2) of this section.

The initial registration period for Salvadorans was from March 9, 2001 through September 9, 2002. The record reveals that the applicant filed the current TPS application with CIS on March 2, 2005.

To qualify for late registration, the applicant must provide evidence that during the initial registration period she fell within at least one of the provisions described in 8 C.F.R. § 244.2(f)(2) above.

The burden of proof is upon the applicant to establish that she meets the above requirements. Applicants shall submit all documentation as required in the instructions or requested by CIS. 8 C.F.R. § 244.9(a). The sufficiency of all evidence will be judged according to its relevancy, consistency, credibility, and probative value. To meet her burden of proof, the applicant must provide supporting documentary evidence of eligibility apart from her own statements. 8 C.F.R. § 244.9(b).

The applicant has failed to provide any evidence to establish that this application should be accepted as a late initial registration under 8 C.F.R. § 244.2(f)(2).

It is noted that the applicant's 2006 FBI fingerprint results report revealed the following additional arrest:

4. On March 10, 2006, the applicant was arrested in Los Angeles, California, and charged with possession of a narcotic controlled substance.

The applicant has failed to provide the final court dispositions of the offenses detailed in Nos. 1 through 3 above. Therefore, she is also ineligible for TPS because of her failure to provide information necessary for the adjudication of her application. 8 C.F.R. § 244.9(a). Additionally, the applicant has not established continuous residence in the United States since February 13, 2001, and continuous physical presence in the United States since March 9, 2001, as described at 8 C.F.R. §§ 244.2(b) and (c). Therefore, the application also must be denied for these reasons.

It is noted that the offense detailed in No. 4 above must be addressed in any further proceeding before CIS.

The application will be denied for the above stated reasons, with each considered as an independent and alternative basis for denial. An alien applying for temporary protected status has the burden of proving that he or she meets the requirements enumerated above and is otherwise eligible under the provisions of section 244 of the Act. The applicant has failed to meet this burden.

ORDER: The appeal is dismissed.
