



DISCUSSION: The application was denied by the Director, California Service Center, and is now before the Administrative Appeals Office on appeal. The appeal will be dismissed.

The applicant claims to be a citizen of El Salvador who is seeking Temporary Protected Status (TPS) under section 244 of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1254.

The director denied the application because the applicant failed to establish that she had been continuously resident and continuously physically present during the required period.

On appeal, counsel for the applicant asserts that a 9th circuit case relieves the applicant from having to satisfy the residence and continuous presence requirements of TPS.

Section 244(c) of the Act, and the related regulations in 8 C.F.R. § 244.2, provide that an applicant who is a national of a foreign state designated by the Attorney General is eligible for TPS only if such alien establishes that he or she:

- (a) Is a national of a state designated under section 244(b) of the Act;
- (b) Has been continuously physically present in the United States since the effective date of the most recent designation of that foreign state;
- (c) Has continuously resided in the United States since such date as the Attorney General may designate;
- (d) Is admissible as an immigrant except as provided under section 244.3;
- (e) Is not ineligible under 8 C.F.R. § 244.4; **and**
- (f)
 - (1) Registers for Temporary Protected Status during the initial registration period announced by public notice in the FEDERAL REGISTER, or
 - (2) During any subsequent extension of such designation if at the time of the initial registration period:
 - (i) The applicant is a nonimmigrant or has been granted voluntary departure status or any relief from removal;
 - (ii) The applicant has an application for change of status, adjustment of status, asylum, voluntary departure, or any relief from removal which is pending or subject to further review or appeal;
 - (iii) The applicant is a parolee or has a pending request for reparole; or

(iv) The applicant is a spouse or child of an alien currently eligible to be a TPS registrant.

- (g) Has filed an application for late registration with the appropriate Service director within a 60-day period immediately following the expiration or termination of conditions described in paragraph (f)(2) of this section.

[Emphasis added]. Persons applying for TPS offered to El Salvadorans must demonstrate continuous residence in the United States since February 13, 2001, and continuous physical presence since March 9, 2001. The initial registration period for Salvadorans was from March 9, 2001, through September 9, 2002. The record reveals that the applicant filed her initial application with Citizenship and Immigration Services (CIS) on May 4, 2005.

To qualify for late registration, the applicant must provide evidence that during the initial registration period she fell within at least one of the provisions described in 8 C.F.R. § 244.2(f)(2) above.

The burden of proof is upon the applicant to establish that he or she meets the above requirements. Applicants shall submit all documentation as required in the instructions or requested by CIS. 8 C.F.R. § 244.9(a). The sufficiency of all evidence will be judged according to its relevancy, consistency, credibility, and probative value. To meet his or her burden of proof, the applicant must provide supporting documentary evidence of eligibility apart from his or her own statements. 8 C.F.R. § 244.9(b).

The director determined that the applicant had admitted she did not arrive in the United States until after the registration period, and denied the application on May 16, 2006. On appeal, counsel for the applicant asserts the applicant is not required to meet the physical presence requirements and cites a 9th circuit case dealing with final orders of removal. The case cited by counsel is irrelevant as the residence and presence requirements are specifically proscribed by statute and federal regulation, and the plain meaning of the statute and regulation clearly state that the residence and continuous presence requirements apply to all initial applications. Section 244(c) of the Act; 8 C.F.R. § 244.2(b), (c). The 9th circuit case cited by the applicant is not persuasive. The court's analysis is inappropriate as it lacks jurisdiction to proscribe federal immigration law, fails to acknowledge Supreme Court precedent and relevant federal statutes (specifically the Administrative Procedure Act) and thus is incorrect as a matter of law. Further, the case cited does not deal with TPS and bears no relevance to these proceedings. The plain meaning of the statute and regulation are clear, the applicant is required to satisfy all of the elements detailed in 8 C.F.R. 244.2(a) through (f) including the late registration and residence and presence requirements.

The applicant has admitted that she did not arrive until August 27, 2003, and is statutorily ineligible for TPS as she cannot establish qualifying continuous residence and physical presence. 8 C.F.R. § 244.2(b) and (c). Consequently, the director's decision to deny the application for TPS will be affirmed.

An alien applying for TPS has the burden of proving that he or she meets the requirements enumerated above and is otherwise eligible under the provisions of section 244 of the Act. The applicant has failed to meet this burden.

ORDER: The appeal is dismissed.
