DISCUSSION: The application for temporary resident status as a special agricultural worker was denied by the Director, Western Service Center, and is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be dismissed.

The director denied the application because the applicant failed to appear for her scheduled interview.

The record reflects that the applicant submitted an appeal on November 20, 1992. The record does not contain that appeal. On October 21, 2004, Citizenship and Immigration Services (CIS) requested that the applicant submit a duplicate copy of the appeal or a new appeal form and forwarded to the applicant blank Forms I-694 Notice of Appeal of Decision for that purpose. The request was sent to the applicant's most current address of record and was returned to CIS undeliverable. Thus, the applicant's failure to receive the request was due to her own making. In the absence of a Form I-694, it cannot be concluded that the applicant waged a meaningful appeal.

In order to be eligible for temporary resident status as a special agricultural worker, an alien must have engaged in qualifying agricultural employment for at least 90 man-days during the twelve-month period ending May 1, 1986, and must be otherwise admissible under section 210(c) of the Act and not ineligible under 8 C.F.R. § 210.3(d). 8 C.F.R. § 210.3(a). An applicant has the burden of proving the above by a preponderance of the evidence. 8 C.F.R. § 210.3(b).

As stated in 8 C.F.R. § 103.3(a)(3)(iv), any appeal which is filed that fails to state the reason for appeal, or is patently frivolous, will be summarily dismissed. Based on the record of proceedings, the applicant has not demonstrated that she addressed the reasons stated in the denial, nor that she provided any additional evidence on appeal. The appeal must therefore be summarily dismissed.

ORDER: The appeal is dismissed. This decision constitutes a final notice of ineligibility.
