

**DISCUSSION:** The District Director, Los Angeles, denied the application for temporary resident status made pursuant to the terms of the settlement agreements reached in *Catholic Social Services, Inc., et al., v. Ridge, et al.*, CIV. NO. S-86-1343-LKK (E.D. Cal) January 23, 2004, and *Felicity Mary Newman, et al., v. United States Immigration and Citizenship Services, et al.*, CIV. NO. 87-4757-WDK (C.D. Cal) February 17, 2004 (CSS/Newman Settlement Agreements). The decision is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected as untimely filed.

The director denied the application because the applicant failed to provide evidence sufficient to show that she entered the United States prior to January 1, 1982 and resided unlawfully in the United States during the requisite period.

An adverse decision on an application for temporary resident status may be appealed to the AAO. The appeal with the required fee must be filed within 30 days after service of the notice of denial. 8 C.F.R. § 245a.2(p). The date of filing is not the date of mailing, but the date of actual receipt. See 8 C.F.R. § 103.2(a)(7)(i). An appeal that is not timely filed will not be accepted. 8 C.F.R. § 245a.2(p).

In this case, the director issued the notice of denial on May 11, 2007 and mailed it to the applicant's address of record. The appeal was received on June 14, 2007, 34 days later. Therefore, the appeal was untimely filed and must be rejected.

**ORDER:** The appeal is rejected.
