DISCUSSION: The application for temporary resident status as a special agricultural worker was denied by the Director, Southern Service Center. It is now before the Administrative Appeals Office on appeal. The appeal will be dismissed.

The director denied the application for lack of prosecution because the applicant failed to appear for the required interview regarding his/her Application for Temporary Residence as a Special Agricultural Worker.

On appeal, the applicant stated that he moved and the interview notice was sent to his old address.

In order to be eligible for temporary resident status as a special agricultural worker, an alien must have engaged in qualifying agricultural employment for at least 90 man-days during the twelve-month period ending May 1, 1986, and must be otherwise admissible under section 210(c) of the Act and not ineligible under 8 C.F.R. § 210.3(d).

Pursuant to 8 C.F.R § 210.2(c)(2)(iv), each alien who filed his application in the United States, regardless of age, must appear at the appropriate Service legalization office and must be fingerprinted. Each applicant shall be interviewed by an immigration officer, except that the interview may be waived when it is impractical because of the health of the applicant.

The applicant was scheduled for his interview on September 9, 1993. However, he failed to appear. Accordingly, the director denied the application on November 5, 1993 as the applicant had failed to present himself for his required interview. On appeal, the applicant stated that the notice was sent to his old address. The applicant was subsequently notified in writing on September 10, 1994 that he was scheduled for a second interview on September 29, 1994. He was also advised that if he did not appear for this interview, his application would be denied for lack of prosecution. The applicant once again failed to appear.

The applicant was provided with two opportunities to appear for his interview. He has failed to comply with Service requirements. Therefore, the applicant is ineligible for temporary resident status as a special agricultural worker.

ORDER: The appeal is dismissed. This decision constitutes a final notice of ineligibility.
