USCIS Announces Fiscal Year 2013 Citizenship and Integration Grant Program Recipients

Nearly \$9.9 Million Awarded to Expand Citizenship Preparation Programs for Permanent Residents in 21 States

Introduction

On Sept. 17, 2013, U.S. Citizenship and Immigration Services (USCIS) announced the award of nearly \$9.9 million in grants designed to prepare permanent residents for citizenship. Under this program, 40 immigrant-serving organizations from 21 states will receive federal funding to support citizenship preparation services for permanent residents through September 2015.

Background

This is the fifth year USCIS has awarded competitive grant funding to immigrant-serving organizations to support citizenship preparation efforts. USCIS has awarded a total of \$33 million through 182 grants to immigrant-serving organizations. To date, these organizations have provided citizenship preparation services to more than 66,000 permanent residents in 31 states and the District of Columbia. USCIS anticipates an additional 31,000 permanent residents will receive citizenship preparation services by September 2015. 1

Under this year's program, grant recipients will offer citizenship instruction to prepare permanent residents for the civics and English components of the naturalization test, and naturalization application services within the scope of the authorized practice of immigration law. The period of performance for the grants is two years.

Recipient Organizations

Recipients are public or private nonprofit organizations with recent experience providing citizenship instruction and naturalization application services to permanent residents. They include public school systems, community and faith-based groups, adult education organizations, and literacy and training organizations.

¹ At least 20,000 permanent residents will be served under the FY 2013 program during its two-year period of performance. An additional 11,000 permanent residents will be served under the ongoing FY 2012 program, which continues through Sept. 30, 2014.

Recipient organizations are geographically diverse and represent both traditional immigrant destinations and new immigrant gateways across 21 states. Grant recipients plan to provide citizenship instruction and naturalization application services to approximately 20,000 permanent residents from more than 50 countries. Grant recipients represent:

- Fifteen of the top 20 states with the largest permanent resident populations eligible to naturalize (California, New York, Texas, Florida, New Jersey, Illinois, Massachusetts, Virginia, Washington, Maryland, Pennsylvania, Michigan, Ohio, Colorado and Minnesota);
- Eight of the top 10 metropolitan areas with the greatest numbers of new permanent residents in the past 10 years (New York City, Los Angeles, Miami, greater Washington, Chicago, San Francisco, Dallas/Fort Worth and Boston); and
- Each of the top 10 states with the largest numbers of naturalizations over the last 10 years (California, New York, Florida, Texas, New Jersey, Illinois, Massachusetts, Virginia, Washington and Maryland).

Review Process

USCIS conducted a thorough review of more than 160 eligible applications. Each proposal was evaluated by a three-member team composed of internal USCIS reviewers. Applications were scored numerically using published evaluation criteria and ordered by rank. The USCIS internal review panel determined the finalists based on the rank order and published strategic program priorities found on page 10 of the funding opportunity announcement.
