[myE-Verify accounts](#) are now available to everyone nationwide. Account holders can use [Self Lock](#) to protect their identity by preventing misuse of their social security number in E-Verify. myE-Verify also includes [Self Check](#) to confirm your own employment eligibility, and [myE-Verify's myResources](#) has helpful information for all workers and job seekers. ## Customer Support Enhanced

Callers to [E-Verify and Form I-9 Customer Support](#) can now expect shorter wait times due to recent technology enhancements. After responding to voice prompts, calls will be quickly routed to a live representative Monday – Friday from 8:00 am to 5:00 pm local time, except on federal holidays.

## Form I-9 Tip

While the email address field is optional for employees completing the [Form I-9](#), entering an email will allow E-Verify to communicate with employees directly. Learn about the four emails an employee may receive from [E-Verify](#).

## E-Verify Tip

How do I create a case for an employee who provided a SENTRI, NEXUS, or Global Entry card (also known as Trusted Traveler card)? The employer should select the employee's correct citizenship or alien status. Next, the employer should indicate that their employee provided 'List B and C Documents' and select 'Continue'. SENTRI, NEXUS or Global Entry cards are acceptable under [List B, #2](#), as an ID card issued by a federal agency.

## E-Verify Keeps Users Up-To-Date on Training

If you last logged into E-Verify prior to December 6, 2010, you've missed tutorials that have since been removed. The next time you log in you will have to take a 45 minute E-Verify tutorial before you can access case data or enter new data.

## News for H-4 Dependent Spouses

Effective May 26, 2015, a regulatory change will extend eligibility for work authorization to H-4 spouses of certain H-1B workers who have already started seeking employment-based lawful permanent resident status. For more information visit the [USCIS website](#).
