- 1. Meeta ówtol lóll Form I-9?** Yaar aweewe me reel Federad nge schóól-attarabwaagho re bwe affataaló bwe alongal ówtorisaal schóól-tarabwaagho re bwe pipiiy me e wewe fengal me rebwe a wela fengaliy. Schóól-attarabwaagho mille re bwe yááyá Form I-9 ngare re bwe féeri. Schóól-attarabwaaghomw e bwe ayeghúugh bwe u bwe sóbweeiló me atakkaalo Section 1. Amwari ghatchúw me árághi ghatchúw nge ischiy-tiw.
- 2. Iyo e ghal amwaschú Form I-9?** Yóómw schóól-atarabwaagho mille e kke amwaschúl Form I-9 ikka aa takkeló, nge e bwe bwal ngalleer akkáv bwulasiol gobietno ngare re tingór. Samwoolul Department of Homeland Security, sáangi Office of Special Counsel for Immigration-Related Unfair Employment Practices (OSC) me rel Department of Justice, me bwal Department of Labor nge re emmwel re bwe inspekta li schóól-atarabwaagho Form I-9.
- 3. I bwe mwákkeitiw alongal lóll Section 1?** Saabw. Eyoor eluww mille re bwe fili me leiyir: (1) Numerol Social Security (2) E-mail Address, me (3) Numerol Tilifon. Ngare schóól atarabwaagho re yááyá E-Verify, nge u bwe ngaleer yóómw numerol Social Security. Ngare u bwe ngaleer yóómw e-mail address me numerol yóómw tilifon, E-Verify e bwe ngallégh milikka e ghi fil bwe u bwe reepiya reel yóómw kkausal E-Verify.
- 4. I bwe atakka ló Section 2 me ngare Section 3?** Saabw Section 2 me Section 3 nge schóól-atarabwaagho re bwe féeril.
- 5. Mille Form I-9 e bwal yoor rel mwaleyeer akkáscháy?** Awer. Form I-9 nge e bwal yoor rel mwaliyer Espaniol re yááyá me Pueto Rico. Lúghúl Pueto Rico nge kkapasal Espaniol mille re ghal yááyá bwe e bwe schéeli ngáliir schóól-tarabwaagho me bwal schóól-atarabwaagho re bwe aweewe me mwaliyál English form.
- 6. Emmwel ascháy iye e repiya kasal English e bwe schéeli yáy rel féeri Form I-9?** Awer. Emmwel u bwe aiyeghi escháy e bwe schéelúgh u bwe atakkaló form. Aweewe nge u bwe yááyá form iye re sáliti ngalúgh mwakkal infotmasion. Aramas ye e schéelúgh bwe sáliti me e atakka ló forms nge e bwal atakka ló "Preparer and/or Translator certification" ul Form I-9. Nge bwal yel u bwe mwákkeitiw itómw rel Section 1.
