



## Understanding the Lists of Deported Immigrants from the Ports of Philadelphia, New York, Boston, and Baltimore [*and other ports*], 1896 - 1902

This series consists of lists of aliens deported from the Ports of Baltimore, Boston, New York and Philadelphia. Shown on each list are the alien's name; age; nationality; the cause of deportation; date of deportation; and port from which returned.
