This chart does not include motions, certifications, or non-merit appeal dispositions (e.g., rejections, summary dismissals, and withdrawals). AAO decisions to remand are indicated because, for certain categories, the AAO may not sustain an appeal and grant a benefit outright until certain administrative tasks are completed by the field office.

Note 1: The FY 21 values for Forms I-129O, I-129P, I-129Q, I-140 NIW, and I-924; the FY 19 value for Form I-140 NIW; and the FY 18 value for Form I-924 were updated to correct errors in the previously reported values.

Note 2: Although Forms I-129CW, I-131, and I-929 were not previously reported in FY 21, the forms were included to help reflect the scope of case types adjudicated.
