FY2016 Citizenship and Assimilation Grant Program Fact Sheet

This fact sheet provides an overview of the characteristics and outcomes for Citizenship Assistance Grant Program (CAGP)¹ participants receiving citizenship preparation services during fiscal year 2016 (FY 2016). The characteristics of CAGP participants highlighted include age, gender, marital status, occupation, country of birth, Lawful Permanent Resident (LPR) class of admission, and length of time in LPR status. Outcomes examined include type of service provided to CAGP participants, naturalization application submission count, English and civics test results including test exemptions, fee waivers, and naturalization rates.

This fact sheet also includes summary CAGP information for FY2014, and FY 2015 compared with FY 2016. USCIS collected the underlying data from CAGP grant recipients and USCIS data systems. In addition, corresponding Lawful Permanent Resident (LPR) data was provided by USCIS Office of Information Technology (OIT). The USCIS Office of Policy and Strategy, Policy Research Division (PRD), Immigration Data Analysis Branch analyzed the data.

During FY 2016, 80 CAGP organizations provided citizenship preparation services to CAGP participants in the District of Columbia and 32 states across the United States. Of these CAGP recipients, 40 received their two-year CAGP grant in September 2014, providing their first year of services in fiscal year 2015 and their second year of services in fiscal year 2016. The other 40 CAGP recipients received their two-year CAGP grant in September 2015, providing their first year of services in fiscal year 2016 and their second year of services in fiscal year 2017.

Each CAGP recipient received approximately \$250,000 in funding for their two-year grants. specifically, CAGP participants are offered citizenship instruction services to prepare for the English and civics portions of the naturalization test, as well as naturalization application services to assist with submitting Form N-400, Application for Naturalization.

In summary, a total of 38,572 individuals participated in the FY 2016 CAGP, up 18% from 32,540 in FY 2015. Meanwhile, the number of N-400 applications associated with FY 2016 was 32,734, up 36% from the 20,760 CAGP participants who submitted form N-400 in FY 2015.

18% of CAGP participants enrolled between October and December 2015, 22% enrolled between January and March 2016., and 60% enrolled between April and September 2016.

As of August 2020, about 62% of FY 2016 CAGP participants had become naturalized U.S citizens compared with 64% for FY 2015 CAGP participants.

FY2016 CAGP Geographic Coverage




Figure 1. FY2016 CAGP Participants Total by County of Birth

In total, FY 2016 CAGP participants were born in 173 different countries. The top five leading countries of birth, comprising 42% of total CAGP participants were: Mexico 23%, Myanmar 5.2%, Iraq 4.6%, Dominican Republic 4.5%, and El salvador 4.5%. (See Figure 1 and Figure 1a)

In comparison, the leading countries of birth for FY 2015 CAGP participants were: Mexico 19%, Iraq 7%, Dominican Republic 5%, Bhutan 4%, Burma 4%, Vietnam 4%, El Salvador 4%, and Colombia 4%.





Figure 1a. FY2016 CAGP Participants Total by County of Birth

Fifty-three percent of FY 2016 CAGP participants lived in five states: California 22%, New York 11%, Texas 10%, Florida 8%, and Illinois 5% (See Figure 2 and Figure 2a). California showed the largest (about 8 percent) increase in FY 2016 compared with FY 2015.


Approximately 50% of all FY 2015 CAGP participants were residing in the following states: California 14.6%, New York 14%, Texas 8.3%, Florida 7.2%, Illinois 6.1%, and Virginia 4.1%




Figure 3. FY2016 CAGP Participants Total -Age Group by Gender

Over one-half of FY2016 CAGP participants were 25 to 44 years old. The median age was 38. The age distribution of CAGP participants was relatively similar for both males and females. (See Figure 3)




Figure 4. FY2016 CAGP Participants Total - World Region by Gender

Over 70% of CAGP participants were born in the following regions: Asia 29%, North America 22%, South America 11%, and the Caribbean 10%. (See Figure 4)




Figure 5. FY2016 CAGP Participants Total – Marital Status by Gender

Females accounted for 61% of all FY2016 CAGP participants. The majority of CAGP participants were married 62%, while 31% were single, 2.5% were divorced and little over 3% were widowed. (See Figure 5)




Figure 6. FY2016 CAGP Participants Total - Admission Class by Gender

Thirty-one percent of FY 2016 CAGP participants gained LPR status after admission as immediate relatives of U.S citizens, while 29% were admitted as refugees and asylees, and another 19% were admitted under family-sponsored preferences. (See Figure 6)




Figure 7. FY2016 CAGP Participants Total - Occupation by Gender

Nearly one-third of FY 2016 CAGP participants reported that they had no occupation or were not working outside the home at the time they applied for naturalization. Of those 7% were unemployed, 13% were homemakers, 12% were students, and 1% reported they were retired; an additional 7% were in service occupations. (See Figure 7)




Figure 8. FY2016 CAGP Participants Total – Years in LPR Status by Gender

CAGP participants had spent a median of eight years in LPR status before becoming U.S. citizens. *(See Figure 8).* FY 2015 CAGP LPR status median duration time was 8 years as well.




Figure 9. FY2016 CAGP Participants Total - Service Type by Gender

About 18% of CAGP participants used both citizenship instruction services and naturalization application services, while 28% used only citizenship instructions services, and 54% used only naturalization application services. (See Figure 9)




Figure 10. FY2016 CAGP Participants Total - –Fee Waiver²

Forty percent of the FY 2016 CAGP participants met the financial hardship eligibility criteria and had their fee waiver request approved. (See Figure 10)



Figure 11. FY2016 CAGP Participants Total- English and Civics Tests Waivers Received



Ninety-one percent (29,747 of 32,734) of FY 2016 CAGP participants who submitted Form N-400, received no exemption from taking any portion of the naturalization test. Of FY 2016 CAGP participants, 90 participants were exempt from taking only the civics test, 1,621 participants were exempt from taking both tests, while another 1,276 participants were exempt from taking only the English test.

* * **Note:** The number of CAGP participants who became naturalized U.S Citizens also includes those who were otherwise eligible for naturalization and either passed both the English and the civics portion of the naturalization test or received an exemption from one or both tests.

About 85% (32,734 of 38,572) of FY2016 CAGP participants submitted Form N-400 based on USCIS data as of August 2020. Over 90% of CAGP participants who applied for naturalization passed either the English or the civics test on the first attempt. 62% of total CAGP participants (23,812 of 38,572) had become naturalized U.S Citizens as of August 2020.
