

Elmgrove, Hersham Road, Walton-on-Thames Surrey.


b) He was convicted May 7, 1969 of possession

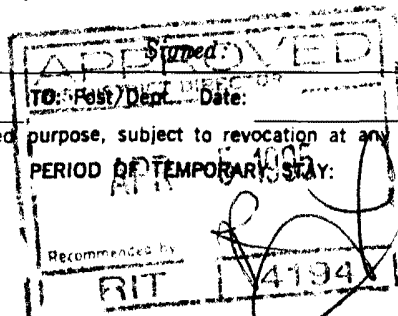

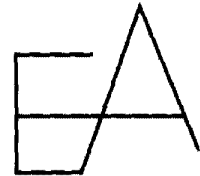

I want to thank you for your help in assisting George Harrison to be admitted despite the fact that he had left England without his visa. I would also like you to express our sincere gratitude to the government, and particularly to your office, for their prompt and efficient action and cooperation in this case.

Please be assured that George was himself, completely without fault in the matter. Because certain extremely important business meetings and negotiations were scheduled to begin promptly on March 12, 1973, and a number of other people had already arrived, and because the meetings required Harrison's personal presence, I insisted that no effort be spared in expediting his arrival here. In their apparent haste to satisfy my request, the English office made the travel arrangements without picking up the necessary visa. This was an obvious and unintentional oversight on their part.

George is quite meticulous about complying with the law in every respect, and I would not like this inadvertent occurrence to be held against him in any way. Gentlemen:

This is in regard to Mr. George Harrison a passenger who was permitted to board your flight PK 701 on March 7, 1973, at London, England notwithstanding it was known he was not in possession of an unexpired visa. This deliberate and unlawful action by your representatives in London provokes me to register my displeasure. More importantly, I am deeply concerned that the gravity of the permissiveness exhibited in this case is not fully comprehended by your duly appointed representatives.

Mr. Harrison arrived at J.F. Kennedy Airport on your PK 701 on March 8, 1973, after having been temporarily diverted to Montreal account of foul weather. He was subsequently granted a waiver of nonimmigrant visa requirement pursuant to authority contained in the Immigration and Nationality Act. Your liability to a \$1000 fine in this case under Section 273 of the Act was thus removed. It does not, however, in any way exculpate your agent's action in London for permitting Mr. Harrison to board the flight knowing he was not in possession of an unexpired visa.

SIC Kerchules, JFK, advised that the subject did not arrive on the evening of March 7, because the Pakistan flight was diverted, because of fog, to Canada. However, the plane was due to arrive very shortly. Mr. Kerchules was asked not to admit the subject if he did arrive, and to contact me; that we would probably require the subject to either withdraw his application or go before a SID and also fine the Airline for letting him aboard.

Shortly thereafter, Mr. Arias, Visa Office, called to report that he had telephoned the London Embassy and had been advised that the subject had not been issued a visa.

Mr. Kerchules, in a return call at about 9:30, advised that the subject had arrived in New York City without a visa, but had a valid passport with an expired B-1 single entry visa, issued in May 1972. Mr. Kerchules stated that the subject had told the examining inspector that his British attorney in Los Angeles, Mr. Coale, had called Harrison the day before and told him that waivers had been issued and that he could get on the plane and come to the United States, which he did.

At Mr. O'Connor's direction, Messrs Lee and Kramer of Burlington were advised of the above, and asked to advise New York to have the subject either withdraw his application for admission or refer him to a SID hearing, and fine the Airline.

Mr. Kramer, in a return call, advised that Mr. Marks had told one of the subject's attorney's, a Mr. Wilder (phonetic), that the subject's entry had been authorized under section 212(d)(3)(A), and that a visa waiver had also been authorized. Mr. Kramer stated that it was his belief that we should go ahead and admit the subject on a visa waiver, because the attorney would likely go into court if we did not.

Mr. O'Connor was furnished the above information and he agreed that the subject should be admitted. I, thereafter, contacted Mr. Arias of the Visa Office and informed him of what had transpired. He stated that he would go along with the reinstitution of the visa waiver. Mr. Kramer of Burlington was then contacted and advised that the subject would be admitted.

About 3:00 p.m., March 7, 1973, Mr. Kramer, Deputy Regional Commissioner, Burlington, telephonically advised that the subject's Business Manager, a Mr. Klien, had advised that he believed the subject was enroute to the United States by plane without obtaining a visa from the American Embassy in London. Mr. Kramer inquired as to the granting of a section 212(d)(3)(A) waiver and a visa waiver. Mr. Kramer was advised that the subject, as well as his wife, had been authorized entry into the United States under section 212(d)(3)(A) by this Service on March 6, 1973, for a period of two months; and that the Visa Office, Department of State had been so notified, the same day. He was advised that I would check with State concerning whether or not the visa waiver had gotten to the Embassy in London, and whether, under the circumstances, a visa waiver would be in order.

I thereafter, contacted Mrs. Dorothy Gilchrist, Visa Office, to whom I had related on March 6, 1973 the information regarding the 212(d)(3)(A) authorization for the subject. I advised her of the above and asked whether or not the 212(d)(3)(A) authorization had been sent to London, and whether the subject could have been issued a visa on the basis of it. She stated that the wire to London had been delayed, and that she was not sure that it had yet been sent by the Visa Office Communications section. Mrs. Gilchrist further stated that following receipt of notification that the waiver had been granted, numerous phone calls have been received from Congressmen, attorney's and others inquiring as to whether or not the subject had been issued a 212(d)(3)(A) waiver.

Mrs. Gilchrist stated that she would refer the request of the visa waiver to Ruth Brooks, who handled these matters. Miss Brooks, thereafter, contacted me and was furnished the above information. She advised that she would be back in touch with me. However, instead, Mr. Julio Arias called me and I related the above information to him. He stated that he believed that a visa waiver should be authorized for both Harrison and his wife, in the event they did arrive without visas, to which I concurred. Mr. Arias stated that he would like to have a report of the facts in the case for use in connection with any future request for a visa by the subject.

Thereafter, at 4:20 p.m., Mr. Kramer, Burlington, was advised that a visa waiver had been authorized.

At 9:00 a.m., March 8, 1973, Mr. Berneen, after conferring with Mr. Arias of the Visa Office, asked that I determine whether or not the subject had arrived, and that if he had not, to advise the OIC at JFK not to admit him if he did not have a visa, but to contact me and that we would then likely not authorize a visa waiver and would proceed with a fine against the Airline.

Mr. George H. Owen, Director, Visa Office, telephoned today as follows concerning subjects:

The American consul, London, and the Visa Office recommend 212(d)(3) authorization for subjects. They desire to come to the United States for one week to engage in business discussions in New York City with their business agent, Allen Klein, and senior officials of UNICEF. The discussions will be concerned with the channeling of funds to the Bangladesh refugees. These funds were raised by the sale of recordings.

The subjects expect to arrive in New York City by January 18, 1972. Thereafter, they plan to go to India about January 24 to meet Prime Minister Gandhi. They will then proceed to Dacca to meet with U. S. representatives with regard to the disposition of the refugee relief fund.

The State Department recommends that the 212(d)(3) authorization permit subjects to enter the United States temporarily during the month of January for a period of 30 days. The favorable recommendation is made because of the humanitarian purpose of the visit which will deal with the channeling of funds for relief of the Bangladesh refugees.

I advised Mr. Owen that the 212(d)(3) temporary admission is authorized as recommended. Mr. Owen will send the Service the usual letter.

On September 30, 1971 Mr. Nolind, T.C. Washington district office, advised that Mr. Brathwaite, Visa Office, had requested and the Washington district office had orally granted a 212(d)(3)(A) waiver on the subject on September 27, 1971.

Mr. Nolind stated that this matter was not brought to the attention of the Central Office prior to the issuance of the order because he was not on duty and the case was handled by new personnel. Mr. Nolind stated he would take steps to insure that future requests for 212(d)(3)(A) orders on Harrison, Lennon and other persons who may receive public attention are presented to the Central Office before the Washington district office takes action. Based on Mr. Brathwaite's recommendation the order authorized the subject one entry on September 30, 1971 for six months.

At your direction, I contacted Mr. Brathwaite to reduce the period of subject's stay if he had not yet been issued a visa. He advised that London requested the 212(d)(3)(A) order on September 23, 1971, indicating the subject wished to enter at New York City on September 30, 1971 for six months to edit a film and tapes for "Bangia Dosh", which covers the Pakistan relief concert held this summer at Madison Square Gardens. Mr. Harrison is providing his services free of charge with the proceeds of the sale of the film and tapes to go to UNICEF to help Pakistani children. It was indicated that this work could not be done in England.

Mr. Brathwaite advised that on September 28, 1971 State wired London authorizing the subject one entry for six months. London by wire September 29, 1971, advised that Mr. Harrison had been issued a B-1 visa and that he will arrive in New York on October 5, 1971 via SS FRANCE.

Mr. Brathwaite was requested to direct future requests for 212(d)(3)(A) waivers for Harrison, Lennon and other similar personalities who may receive public attention in the U.S., which would result in unfavorable publicity, to this office. He assured me that this would be done.

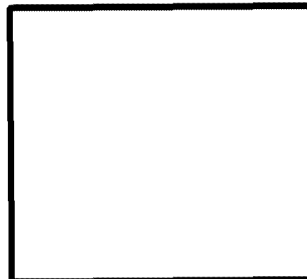

Mr. Precht stated he was calling to notify the Immigration and Naturalization Service so that the subjects would not use the petition filed by Ed Sullivan Productions to gain entry into the United States.
