I would also like you to express our sincere gratitude to the government, and particularly to your office, for their prompt and efficient action and cooperation in this case.

Please be assured that George was himself, completely without fault in the matter. Because certain extremely important business meetings and negotiations were scheduled to begin promptly on March 12, 1973, and a number of other people had already arrived, and because the meetings required Harrison's personal presence, I insisted that no effort be spared in expediting his arrival here. In their apparent haste to satisfy my request, the English office made the travel arrangements without picking up the necessary visa. This was an obvious and unintentional oversight on their part.

George is quite meticulous about complying with the law in every respect, and I would not like this inadvertent occurrence to be held against him in any way. Likewise, I would like the government to know that their special courtesies extended in this case are sincerely appreciated by us all and that this type of occurrence is not likely to ever be repeated.

The latter stated that the Service had recently refused a 212(d)(3) waiver on behalf of subject on the ground that he had overstayed his authorized stay in this country. However, the corporate attorney alleges that, slthough subject's stay originally expired on June 1, 1973, the subject had personally appeared at an unspecified INS office in California and that the officer handling extension of stay at that office had endorsed Harrison's Form I-94 to indicate that his departure on or before June 30 would be satisfactory. Subject allegedly departed on June 28.

Mr. Fried requested that, in fairness to the subject, the Service should recheck, its records and that, if the record showed that he had effected a timely departure and the alleged overstay was the only basis for refusal of the 212(d)(3) authorization, that the Service give further consideration thereto.



Gentlemen:

This is in regard to Mr. George Harrison a passenger who was permitted to board your flight PI 701 on March 7, 1973, at London, England notwithstanding it was known he was not in possession of an unexpired visa. This deliberate and unlawful action by your representatives in London provokes me to register my displeasure. More importantly, I am deeply concerned that the gravity of the permissiveness exhibited in this case is not fully comprehended by your duly appointed representatives.

Mr. Harrison arrived at J.F. Kennedy Airport on your PK 701 on March 8, 1973, after having been temporarily diverted to Montreal account of foul weather. He was subsequently granted a waiver of nonimmigrant visa requirement pursuant to authority contained in the Immigration and Mationality Act. Your Hability to a \$1000 fine in this case under Section 273 of the Act was thus removed. It does not, however, in any way exculpate your agent's action in London for permitting Mr. Herrison to board the flight knowing he was not in possession of an unexpired visa.

Mr. George H. Owen, Director, Visa Office, telephoned today as follows concerning subjects:

The American consul, London, and the Visa Office recommend 212(d)(3) authorization for subjects. They desire to come to the United States for one week to engage in business discussions in New York City with their business agent, Allen Klein, and senior officials of UNICEF. The discussions will be concerned with the channeling of funds to the Bangladesh refugees. These funds were raised by the sale of recordings.

The subjects expect to arrive in New York City by January 18, 1972. Thereafter, they plan to go to India about January 24 to meet Prime Minister Ghandi. They will then proceed to Dacca to meet with U. S. representatives with regard to the disposition of the refugee relief fund.

The State Department recommends that the 212(d)(3) authorization permit subjects to enter the United States temporarily during the month of January for a period of 30 days. The favorable recommendation is made because of the humanitarian purpose of the visit which will deal with the channeling of funds for relief of the Bangladesh refugees.

I advised Mr. Owen that the 212(d)(3) temporary admission is authorized as recommended. Mr. Owen will send the Service the usual letter.


Vise Petition by Sullivan Productions for John W. O. Lennon, and George Harrison, _____ (Members of the "Beatles") (b)(6)

Mr. P. A. Esperdy, District Director, New York City telephoned on February 25, 1970 to advise that Mr. Bob Precht, representing Ed Sullivan Productions, telephoned today to advise that the services of the "Beatles" were no longer needed or desired by Ed Sullivan Productions. Mr. Precht stated he was calling to notify the Immigration and Naturalisation Service so that the subjects would not use the petition filed by Ed Sullivan Productions to gain entry into the United States.

I immediately notified Mr. George H. Owen, Director, Visa Office, Department of State of the foregoing. He stated he would call the Embassy in London to ascertain whether visas had been issued. If they have been issued and the subjects have not embarked to the United States he will issue instructions to cancel the visas.

Mr. Owen advised on February 26, 1970 that the American Embassy at London had informed him that visas had not been issued to the subjects and since the petitioner did not desire their services the visas would be refused.


