



## **Highlights:**

- **Site Traffic Declines Modestly:** This past month, traffic dropped 6% to just over 10.6 million total sessions, still a relatively high overall level of traffic.
- DACA Numbers Rise: Visitors searching for information on DACA renewal drove searches for DACA and traffic to DACA related pages up in June.
- World Refugee Day Tweets Make an Impression: Our top two tweets for June highlighted World Refugee Day and linked to a video on the Director's personal connection to refugee issues.
