DISCUSSION: The Director, California Service Center, denied the employment based immigrant visa petition. The matter is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected as untimely filed.

In order to properly file an appeal, the regulation at 8 C.F.R. § 103.3(a)(2)(i) provides that the affected party must file the complete appeal within 30 days after service of the unfavorable decision. If the decision was mailed, the appeal must be filed within 33 days. *See* 8 C.F.R. § 103.5a(b). The date of filing is not the date of mailing, but the date of actual receipt. *See* 8 C.F.R. § 103.2(a)(7)(i).

The record indicates that the director issued the decision on November 9, 2010, and properly gave notice to the petitioner that it had 33 days in which to file the appeal. The regulation at 8 C.F.R. § 103.3(a)(2) states an appeal must be accompanied by a nonrefundable fee as set forth in 8 C.F.R. § 103.7. As of November 23, 2010, the fee for filing a Form I-290B, Notice of Appeal or Motion, is \$630.00. 75 Fed. Reg. 58962 (Sept. 24, 2010). An application or petition that is submitted with the wrong filing fee shall be rejected as improperly filed and will not retain a filing date. 8 C.F.R. § 103.2(a)(7)(i).

The petitioner submitted an appeal to the California Service Center on December 10, 2010, along with an incorrect fee of \$585. The director returned the appeal and notified the petitioner of the correct fee for filing an appeal. The appeal, with the correct filing fee, was filed with the California Service Center on December 22, 2010, or 43 days after the director issued her decision. Accordingly, the appeal was untimely filed.

The regulation at 8 C.F.R. § 103.3(a)(2)(v)(B)(2) states that if an untimely appeal meets the requirements of a motion to reopen or a motion to reconsider, the appeal must be treated as a motion, and a decision must be made on the merits of the case. The official having jurisdiction over a motion is the official who made the last decision in the proceeding, in this case the Director of the California Service Center. *See* 8 C.F.R. § 103.5(a)(1)(ii). The director determined that the late appeal did not meet the requirements of a motion and forwarded the matter to the AAO.

As the appeal was untimely filed, the appeal must be rejected.

ORDER: The appeal is rejected.
