



DISCUSSION: The Director, Texas Service Center, initially approved the employment-based immigrant visa petition. The matter was subsequently transferred to the California Service Center. Upon further review, the Director, California Service Center, (“the director”) determined that the petition had been approved in error. The director properly served the petitioner with a notice of intent to revoke, and subsequently revoked the approval of the petition. The matter is now before Administrative Appeals Office (“AAO”) on appeal. The AAO will withdraw the director’s decision and remand the petition to the director for further consideration and action.

The petition was initially approved on April 25, 2006. The revocation at issue in the instant matter is erroneously based upon regulations that became effective on November 26, 2008, after the initial approval of the petition. Accordingly, the director must issue a new notice and decision based upon the regulations in effect at the time of the approval of the petition.

As always in these proceedings, the burden of proof rests solely with the petitioner. Section 291 of the Act, 8 U.S.C. § 1361.

ORDER: The matter is remanded to the director, California Service Center, for the issuance of a new notice and decision. If the new decision is adverse to the petitioner, it shall be certified to the AAO for review.
