



DISCUSSION: The director of the service center denied the nonimmigrant visa petition and the matter is now before the Administrative Appeals Office (AAO) on appeal. The appeal will be rejected.

The petitioner is an accounting services firm that seeks to employ the beneficiary as an “accounting systems processing.” The petitioner, therefore, endeavors to classify the beneficiary as a nonimmigrant worker in a specialty occupation pursuant to section 101(a)(15)(H)(i)(b) of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1101(a)(15)(H)(i)(b).

An immigration consultant prepared the appeal. Although the appeal is accompanied by a Form G-28, Notice of Entry of Appearance by an Attorney or Representative, the immigration consultant has not established that he is a licensed attorney or an accredited representative authorized to undertake representations on the petitioner’s behalf. *See* 8 C.F.R. § 292.1. Accordingly, the assertions of the immigration consultant will not be considered.

ORDER: The appeal is rejected.
