DISCUSSION: The nonimmigrant visa petition was denied by the Director, Vermont Service Center. The matter is now before the Administrative Appeals Office (AAO) on appeal. The AAO will dismiss the appeal as moot.

The petitioner filed the nonimmigrant petition to classify the beneficiary as an L-1B intracompany transferee pursuant to section 101(a)(15)(L) of the Immigration and Nationality Act (the Act), 8 U.S.C. § 1101(a)(15)(L). The petitioner sought to temporarily transfer the beneficiary to the United States as an employee with specialized knowledge for a period of two years.

The director denied the petition on May 16, 2008, and the petitioner filed a timely appeal.

On May 10, 2013, the petitioner, through counsel, requested that the AAO adjudicate the appeal as moot because the beneficiary's requested period of employment had passed.

Accordingly, the AAO finds that the passage of time has deprived this appeal of any practical significance. Considerations of prudence warrant the dismissal of the appeal as moot. *See Matter of Luis*, 22 I&N Dec. 747, 753 (BIA 1999).

ORDER: The appeal is dismissed as moot.
