DISCUSSION: The Acting Center Director, Vermont Service Center, denied the applicant employment authorization. The matter is now before the Administrative Appeals Office (AAO) on appeal. The matter will be remanded for further action consistent with this decision.

The applicant is a native and citizen of Honduras who filed an initial Application for Temporary Protected Status (Form I-821) on August 18, 1999. USCIS records indicate that on March 22, 2000, the Form I-821 was rejected due to check deficiency. The applicant subsequently filed a Form I-821 and an Application for Employment Authorization (Form I-765) to apply for the re-registration of Temporary Protected Status (TPS) on May 30, 2013.

On December 19, 2013, the acting center director issued a decision indicating that the applicant was not eligible for employment authorization based on the prior rejection of the initial Form I-821, but the acting center director did not address the applicant's current application for re-registration, and there is no other decision for this application in the record. On appeal, the applicant indicates he is seeking review of the acting center director's TPS determination. Consequently, we deem the applicant's appeal an appeal of the denial of his re-registration application. Insofar as the record does not contain a decision on that application, and the acting center director's decision of December 19, 2013 does not address that application, the matter will be remanded for the issuance of a decision on the TPS re-registration application. If that decision is adverse to the applicant, the director shall certify it to the AAO for review.

ORDER: The matter is remanded for issuance of a decision on the application for TPS re-registration.
